AS OF TODAY 4-18-2018, ALL SIR GOLF EVENTS, WHICH INCLUDE THE STATE TEAM CHAMPIONSHIPS AND INDIVIDUAL CHAMPIONSHIPS WILL REQUIRE GOLFERS ONLY TO BE AN ACTIVE MEMBER OF A SIR BRANCH IN GOOD STANDING WITH ANY VERIFIABLE INDEX.

This also includes the eligibility for the Feather In the Cap Award.

In order to enhance participation in the Team Qualifier, we have added a \$100 prize to the top finishing Team in each Area Qualifier. By removing the requirement to have a SIR NCGA Index to qualify, we are hoping to fill the field and promote more participation.

SIRS Baseball at Oakland Coliseum

Sir Lee Moy of Fresno organized a baseball outing for all Sirs and their wives for the Giants vs. A's game at Oakland Coliseum on Sunday, July 22. My wife Olivia and I signed up for this event several months ago, and attended the game yesterday with 38 other Sirs and their wives from numerous other Branches.

We drove to the game on a beautiful Sunday morning. I-80 moved quite well, but got very jammed from Richmond to the I-580 turn to Oakland. Because both the Giants and A's are playing well this year, the game attracted a big crowd of over 46,000. Traffic around the Stadium was heavy, so we parked in an outer private lot for \$10, hoping that our car would still be there after the game. (It was!) We walked in on the footbridge from the BART station, and joined the Sirs in our fine seats along the right field line.

We were seated near Sir Lee Moy from Fresno who set up the event. Lee was pleased that we had 38 attendees, but hopes for more next year The stadium was loud and raucous, divided between loyal A's fans and visiting Giants fans (including me and Livy). The game was back and forth and very exciting, right to the end, when the A's won 6 to 5 in the 10th inning on a flukey ground ball that popped up in the infield and was mishandled by our All Star shortstop, Brandon Crawford. The game included two home runs each from Matt Olson and Khris Davis, one from Andrew McCutcheon, and a two-run pinch hit single by Pablo Sandoval. The A's won the 6 game series with the Giants 4 games to 2, but it easily could have been the other way around. Both teams could make the playoffs.

Our Giants lost, but it was a great day overall. We let "Suri" the "phone lady" guide us home, taking us to I-680 in Concord to avoid I-80 traffic. Very gusty crosswinds on I-680 to Fairfield, but the rest of the way home was uneventful. We hope that next year we may have some company from Branch 112 for a fun day of baseball!
